

1 [Appointment - Asthma Task Force]

3 **Resolution appointing Tiffany Sutter, term ending June 30, 2007, to the Asthma Task**  
4 **Force, residency requirement waived.**

5  
6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
7 does hereby appoint the hereinafter designated person to serve as a member of the Asthma  
8 Task Force, pursuant to the provisions of the San Francisco Administrative Code, Chapter  
9 19A, Article II, for the term specified:

10 Tiffany Sutter (residency requirement waived), succeeding Micah McLorin, resigned,  
11 seat 13, must be a representative of lung health/asthma-specific organizations and is a voting  
12 member, for the unexpired portion of a two-year term ending June 30, 2007; and, be it

13 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 14 1. The membership of the Asthma Task Force has a goal to be representative of the  
15 diversity of the City and County of San Francisco.
- 16 2. Applicant Tiffany Sutter, a new appointee, who is not a resident of San Francisco, is  
17 a person with experience that uniquely qualifies her to serve on the Asthma Task  
18 Force.
- 19 3. The Asthma Task Force has attempted to fill the position, for which Tiffany Sutter  
20 was nominated, with an individual who is a City resident and who has the specific  
21 experience, skills, and qualifications, but has been unable to do so at this time. The  
22 Rules Committee has certified that Tiffany Sutter is qualified to serve on the Asthma  
23 Task Force.
- 24 4. After exercising due diligence, the Board of Supervisors concludes that there is no  
25 other possible representative, who is a resident of San Francisco and who has the

1 specific experience, skills, or qualifications possessed by this applicant, and who is  
2 willing to serve on the Asthma Task Force at this time; and, be it

3 FURTHER RESOLVED, That the Board of Supervisors waives the residency  
4 requirement for Tiffany Sutter, as allowed in cases where no qualified City resident, willing to  
5 serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s)  
6 appointed to boards, commissions, and advisory bodies established by legislative act of the  
7 Board of Supervisors to be resident(s) of the City and County of San Francisco.
