3 **Resolution authorizing the San Francisco Public Utilities Commission to accept and**
4 **expend a CALFED Water Use Efficiency Grant in the amount of \$299,390 through the**
5 **United States Department of the Interior, Bureau of Reclamation.**

6 WHEREAS, The Bureau of Reclamation (Reclamation) announced the availability of
7 \$2.4 million in Federal funds from the CALFED Water Use Efficiency Grants Program for
8 agricultural and urban grants to implement water use efficiency projects; and

9 WHEREAS, The SFPUC applied for grant funding through the CALFED Water Use
10 Efficiency Grants Program for a Water Loss Reduction Program to install the latest electronic
11 leak detection devices throughout the water transmission and distribution system to reduce
12 water loss through enhanced leak detection time; and,

13 WHEREAS, Reclamation notified the SFPUC on September 7, 2006 that it had
14 approved a grant award of \$299,390; and

15 WHEREAS, THE SFPUC proposes to maximize use of available grant funds on
16 program expenditures by not including indirect costs in the grant budget; and


17 WHEREAS, The San Francisco Public Utilities Commission on April 25, 2006, adopted
18 resolution no. 06-0067 authorizing the General Manager to request permission from the Board
19 of Supervisors to accept and expend CALFED Water Use Efficiency grant funds; now,
20 therefore, be it


21 **RESOLVED**, That the General Manager of the San Francisco Public Utilities


