4 **Resolution authorizing Tax Collector Attorney to file suit against responsible relative to**  
5 **recover value of services rendered at hospital facilities operated by the San Francisco**  
6 **Department of Public Health.**

8 WHEREAS, It appears from the San Francisco Treasurer and Tax Collector's letter  
9 dated August 21, 2006, identifying those recipients of medical aid at San Francisco medical  
10 facilities who have relatives legally liable for the cost of medical treatment rendered to their  
11 kindred, which letter is on file with the Clerk of the Board of Supervisors in File No. 061400,  
12 which is hereby declared to be a part of this resolution as if set forth fully herein; and,

13 WHEREAS, It further appears that the Tax Collector has determined that each of the  
14 below-named relatives has the financial ability to pay for the aid rendered to their kindred at  
15 San Francisco Department of Public Health both at the time the aid was rendered and at the  
16 present time; now, therefore, be it

17 RESOLVED, That the Tax Collector Attorney be, and hereby is authorized and directed  
18 to institute legal proceedings against the herein named relative deemed responsible for the  
19 payment of said medical services, and to seek recovery in full of charges for medical aid  
20 rendered at San Francisco Department of Public Health medical facilities pursuant to Section  
21 17300 of the California Welfare and Institutions Code.


