3 **Resolution appointing Sarah Leiber Church and Virginia Villegas, terms ending**
4 **December 17, 2007, to the Sweatfree Procurement Advisory Group, residency**
5 **requirement waived.**

7 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
8 does hereby appoint the hereinafter designated persons to serve as members of the
9 Sweatfree Procurement Advisory Group, pursuant to the provisions of Board of Supervisors
10 Ordinance No. 223-05, for the term specified:

11 Sarah Leiber Church (residency requirement waived), succeeding Abigail Levine,
12 resigned, seat 3, must have significant experience as an advocate for human rights or the
13 poor, for the unexpired portion of a two-year term ending December 17, 2007.

14 Virginia Villegas, succeeding Dale Jiajun Wen, resigned, seat 5, must be a member of
15 the public, for the unexpired portion of a two-year term ending December 17, 2007; and, be it

16 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 17 1. The membership of the Sweatfree Procurement Advisory Group has a goal to be
18 representative of the diversity of the City and County of San Francisco.
- 19 2. Applicant Sarah Leiber Church, a new appointee, who is not a resident of San
20 Francisco, is a person with experience that uniquely qualifies her to serve on the
21 Sweatfree Procurement Advisory Group.
- 22 3. The Sweatfree Procurement Advisory Group has attempted to fill the position, for
23 which Sarah Leiber Church was nominated, with an individual who is a City resident
24 and who has the specific experience, skills, and qualifications, but has been unable

1 to do so at this time. The Rules Committee has certified that Sarah Leiber Church
2 is qualified to serve on the Sweatfree Procurement Advisory Group.

- 3 4. After exercising due diligence, the Board of Supervisors concludes that there is no
4 other possible representative, who is a resident of San Francisco and who has the
5 specific experience, skills, or qualifications possessed by this applicant, and who is
6 willing to serve on the Sweatfree Procurement Advisory Group at this time; and, be
7 it

8 FURTHER RESOLVED, That the Board of Supervisors waives the residency
9 requirement for Sarah Leiber Church, as allowed in cases where no qualified City resident,
10 willing to serve, can be found, pursuant to Section 4.101 of the City Charter that requires
11 person(s) appointed to boards, commissions, and advisory bodies established by legislative
12 act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.




