6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
7 does hereby appoint the hereinafter designated persons to serve as members of the Shelter  
8 Monitoring Committee, pursuant to the provisions of Ordinance No. 283-04 and Article XII of  
9 Article 20 of the San Francisco Administrative Code, for the terms specified:

10 Maxine Pauson, succeeding herself, term expired, seat 1, must be homeless or  
11 formerly homeless, for the unexpired portion of a two-year term ending November 23, 2008.

12 Elizabeth Olsen, succeeding herself, term expired, seat 2, must be homeless or  
13 formerly homeless, for the unexpired portion of a two-year term ending November 23, 2008.

14 Diana Valentine, succeeding herself, term expired, seat 3, must have experience  
15 providing direct services to the homeless through a community setting, for the unexpired  
16 portion of a two-year term ending November 23, 2008.

17 Kim Clark, succeeding Bianca Henry, term expired, seat 4, must be selected from a list  
18 of candidates that are nominated by community agencies that provide behavioral health,  
19 housing placement, or other services to the homeless, for the unexpired portion of a two-year  
20 term ending November 23, 2008.

21 Damian Ochoa, succeeding himself, term expired,, seat 6, must be selected from a list  
22 of candidates that are nominated by non-profit agencies that provide advocacy or organizing  
23 services to homeless people, for the unexpired portion of a two-year term ending November  
24 23, 2008.
