3 **Resolution authorizing the Department of the Environment to accept and expend a**
4 **grant in the amount of \$49,980.00 from the California Integrated Waste Management**
5 **Board for the purpose of increasing the Re-Use of Construction and Demolition**
6 **materials in the City and County of San Francisco.**

8 WHEREAS, After a competitive process, the California Integrated Waste Management
9 Board has selected the City and County of San Francisco to receive a grant of \$49,980.00 to
10 increase the re-use of Construction and Demolition materials; and,

11 WHEREAS, San Francisco has one of the most ambitious diversion goals in the state,
12 calling for diversion rates of 75% by 2010 and zero-waste by 2020; and,

13 WHEREAS, Construction and Demolition waste contributes to the overall waste stream
14 in the City and County of San Francisco; and,

15 WHEREAS, The City and County of San Francisco passed a Construction and
16 Demolition Ordinance (27-06) effective on July 1, 2006 which creates a mandatory program to
17 maximize the recycling of construction and demolition waste materials; and,

18 WHEREAS, This Ordinance requires that mixed construction and/or demolition debris
19 be transported off site by a Registered Transporter and taken to a Registered Facility that will
20 process, recycle and divert from landfills a minimum of 65% of the waste material generated
21 from construction, demolition or remodel projects; and,

22 WHEREAS, This grant supports the implementation of the new Construction and
23 Demolition Ordinance by providing funds for outreach, education and technical assistance to
24 those involved in the construction and demolition trades about the ordinance; and,

1 WHEREAS, This grant also helps SF Environment to provide education on the
2 appropriate re-use of Construction and Demolition materials; and,

3 WHEREAS, By providing innovative strategies and procedures to foster change in the
4 waste management and waste disposal aspects of the construction industry, the City and
5 County of San Francisco will benefit from a reduction in Construction and Demolition waste,
6 and will support the transformation of the salvage/recycling industries; and,


7 WHEREAS, This grant will help the City and County of San Francisco to reach its
8 ambitious waste diversion goals; and,

9 WHEREAS, This grant does not require an ASO amendment; and,


10 WHEREAS, The grant budget includes provision for indirect costs of \$2,380.00; now,




