9 WHEREAS, In February 1978, Kay Gulbengay was promoted to serve as
10 Administrator of the Assessment Appeals Board overseeing property tax appeals; and

11 WHEREAS, In July 1988, because of her remarkable service, Kay Gulbengay
12 was again promoted to the Assistant Clerk position where she admirably served until
13 December 1994, when she became the Executive Assistant to the Director of the
14 Employees' Retirement System; and

15 WHEREAS, Seeking a more challenging work environment, in June 2002, Kay
16 Gulbengay returned to the Clerk's Office to become the Deputy Clerk managing the
17 Legislative Division; and

18 WHEREAS, Kay Gulbengay's grasp of the legislative process rivals that of the
19 best legislators and aides alike; and

20 WHEREAS, Kay Gulbengay has navigated the most politically charged room in
21 City Hall with grace and humor; and

WHEREAS, Kay Gulbengay's long career of outstanding service and contribution to the City and County of San Francisco have been a benefit to citizens and city employees alike; and

WHEREAS, She will be greatly missed by her colleagues and friends here at City Hall; now, therefore, be it

RESOLVED, That the Board of Supervisors commends Kay Gulbengay for her 40 years of dedicated service and wishes her well on her retirement; and, be it


