3 **Resolution determining that the reactivation and transfer of a Type 20 off-sale**  
4 **beer and wine license from 1306 Fulton Street to 1302 Fulton Street, to Khaled S.**  
5 **Dajani, for Café Abir, Inc., will serve the public convenience and necessity of the**  
6 **people of the City and County of San Francisco, in accordance with Section**  
7 **23958.4 of the California Business and Professions Code, with conditions.**

9 WHEREAS, Khaled S. Dajani is seeking reactivation and transfer of a Type 20  
10 off-sale beer and wine license from 1306 Fulton Street to 1302 Fulton Street for Café  
11 Abir, Inc.; and,

12 WHEREAS, The Planning Department has verified that the area is properly  
13 zoned; and,

14 WHEREAS, The Police Department recommends that the liquor license  
15 application be approved with conditions; now, therefore, be it

16 RESOLVED, That in accordance with Section 23958.4 of the California Business  
17 and Professions Code, the Board of Supervisors of the City and County of San  
18 Francisco hereby determines for the foregoing reasons that the reactivation and transfer  
19 of a Type 20 off-sale beer and wine license, to Khaled S. Dajani for Café Abir, Inc.,  
20 located at 1302 Fulton Street, will serve the public convenience and necessity of the  
21 people of the City and County of San Francisco.

22 Conditions: (1) The sale and service of alcoholic beverages shall be permitted  
23 only between the hours of 9:00 a.m. and 12:00 midnight each day of the week. (2)  
24 There shall be no coin operated games or video machines maintained upon the  
25 premises at any time. (3) Loitering (loitering is defined as "to stand idly about; linger

1 aimlessly without lawful business”) is prohibited on any sidewalks or property adjacent  
2 to the licensed premises under the control of the licensee as depicted on the ABC-257,  
3 dated November 7, 2006. (4) The petitioner(s) shall be responsible for maintaining free  
4 of litter the area adjacent to the premises over which they have control. (5) The sale of  
5 any beer and/or malt product(s) is strictly prohibited.




