3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**  
4 **retroactively accept and expend two grants from the California Department of Food and**  
5 **Agriculture in the amounts of \$63,888 and \$42,076 (for a total of \$105,964) in support of**  
6 **the Pierce's Disease Control Program and the High Risk (Pest Exclusion) Program for**  
7 **the period of July 1, 2006 to June 30, 2007.**

9 WHEREAS, SFDPH - Environmental Health Section, Agriculture Program has applied  
10 for and been awarded two grants from the California Department of Food and Agriculture  
11 (CDFA), including \$63,888 in support of the Pierce's Disease Control Program and \$42,076 in  
12 support of the High Risk (Pest Exclusion) Program; and,

13 WHEREAS, As a condition of receiving the grant funds, the CDFA require the City to  
14 comply with the terms of two agreements (the "Agreements"), copies of which are on file with  
15 the Clerk of the Board of Supervisors in File No. 070098, which is hereby declared  
16 to be a part of this resolution as if set forth fully herein; and,

17 WHEREAS, The grant budget includes a provision for indirect costs of \$11,265.25 for  
18 the Pierce's Disease Control Program and \$28,116 for the High Risk (Pest Exclusion)  
19 Program; now, therefore, be it

20 RESOLVED, That SFDPH is hereby authorized to retroactively accept and expend two  
21 grants in the total amount of \$105,964 from the CDFA; and, be it


22 FURTHER RESOLVED, That SFDPH is hereby authorized to accept and expend the  
23 grant funds in accordance with the requirements set forth in the Agreement, pursuant to San  
24 Francisco Administrative Code section 10.170-1; and, be it

FURTHER RESOLVED, That the Director of Health is authorized to enter into the Agreements on behalf of the City.




