

1 [Prevailing rate of wages for City contracts for hauling of solid waste generated by City
2 operations.]

3 **Resolution fixing prevailing wage rates for workers engaged in the hauling of solid**
4 **waste generated by the City in the course of City operations, pursuant to a contract**
5 **with the City.**

7 WHEREAS, Administrative Code Section 21.25-5 requires that every contract awarded
8 by the City and County of San Francisco (the "City") for the hauling of solid waste generated
9 by the City in the course of City operations require that any employee engaged in the hauling
10 of solid waste be paid not less than the prevailing rate of wages, including wages for holiday
11 and overtime work, and fringe benefits or the equivalent thereof, as paid in private
12 employment for similar work in the area where the contract is being performed; and

13 WHEREAS, For the foregoing purpose, Administrative Code Section 21.25-5 requires
14 the Board of Supervisors (the "Board") to fix and determine the prevailing rate of wages for
15 individuals engaged in the hauling of solid waste, including wages for holiday and overtime
16 work, and fringe benefits or the equivalent thereof, as paid for similar work in the City in
17 private employment; and

18 WHEREAS, To aid the Board in the aforementioned determination of prevailing wage
19 rates, Administrative Code Section 21-25.5 requires the Civil Service Commission ("the
20 Commission") to furnish to the Board relevant data as to prevailing wage rates; and

21 WHEREAS, The Commission at its January 16, 2007 meeting had for its consideration
22 the Certification of the Prevailing Rate of Wages for Workers Engaged in Hauling Solid Waste
23 Generated by the City in the Course of City Operations, and for that purpose reviewed a
24 report on that subject prepared by the Department of Human Resources ("DHR"), on file with
25 the Clerk of the Board in File No. ⁰⁷⁰⁰⁶⁶, which is hereby declared to be a part of this

1 resolution as if set forth fully herein; and

2 WHEREAS, The Commission at its January 16, 2007 meeting decided to certify the
3 data in and adopt the aforementioned DHR report, which includes conclusions as to the
4 prevailing wage rates applicable to workers covered by Administrative Code Section 21.25-5;
5 now, therefore, be it

6 RESOLVED, That, pursuant to Administrative Code Section 21.25-5, the Board fixes
7 and determines the prevailing rate of wages, including wages for holiday and overtime work,
8 and fringe benefits or the equivalent thereof, paid to employees engaged in the hauling of
9 solid waste, to be the wages identified in the aforementioned DHR report, specifically,
10 provisions of the Collective Bargaining Agreement Between Norcal Waste Systems, Inc.,
11 Golden Gate Disposal & Recycling Company, and Sunset Scavenger Company, and Sanitary
12 Truck Drivers and Helpers Union Local 350, International Brotherhood of Teamsters.
