8 WHEREAS, The Chief of Police of the City and County of San Francisco desires to  
9 accept, install, staff, utilize and maintain awarded telephone analysis software from resources  
10 made available in part through the Technology Transfer Program, Office of National Drug  
11 Control Policy, Counterdrug Technology Assessment Center (ONDCP/CTAC); and,

12 WHEREAS, The utilization of this counterdrug technology software will provide material  
13 evidence to greatly assist law enforcement efforts to disrupt the illicit drug markets and  
14 associated homicides; now, therefore, be it

15 RESOLVED, That the Chief of Police of the city and County of San Francisco is  
16 authorized on behalf of the City and County of San Francisco to retroactively accept, install,  
17 utilize and maintain awarded telephone analysis software from the ONDCP/CTAC; and be it

18 FURTHER RESOLVED, That The Chief of Police of the City and County of san  
19 Francisco is authorized to execute on behalf of the City and County of San Francisco the  
20 necessary Technology Transfer Program Agreement for this project including any extensions,  
21 funding augmentations from the Office of National Drug Control Policy, Counterdrug  
22 Technology Assessment Center, or amendments thereof; and be it


23 FURTHER RESOLVED, That it is agreed that any liability arising out of the


