3 **Resolution approving an Agreement between the City and County of San Francisco**
4 **(Purchaser) and Sunset Scavenger, Golden Gate Disposal & Recycling Company, and**
5 **SF Recycling & Disposal Company, Inc. (Contractors) for refuse services, resulting in**
6 **total compensation to the Contractors in an amount not to exceed \$23,500,000,**^{\$23,037,527}
7 **pursuant to San Francisco Charter Section 9.118(b).**

9 WHEREAS, The City historically has contracted for collection of refuse generated by
10 City departments and facilities through a series of annual purchase orders; and

11 WHEREAS, The Purchaser and the Contractors propose to enter into an agreement for
12 collection of refuse generated by City departments and facilities for a term of approximately
13 4 and one-half years, with two additional one-year options, and compensation to Contractors
14 not to exceed \$23,500,000^{\$23,037,527} for the initial term; and,

15 WHEREAS, San Francisco Charter Section 9.118(b) provides that the agreements
16 entered into by a department, board, or commission requiring anticipated expenditures by the
17 City and County of ten million dollars, shall be subject to approval of the Board of Supervisors
18 by resolution; and,

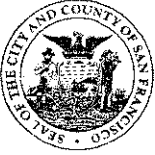
19 WHEREAS, The Agreement is on file with the Clerk of the Board of Supervisors in File
