Rennie for The Bar Downtown, LLC dba The Bar Downtown, will serve the public convenience and necessity of the people of the City and County of San Francisco, in accordance with Section 23958.4 of the California Business and Professions Code, with conditions.

WHEREAS, Michael E. Renne is seeking the transfer of a Type 48 on-sale general public premises license from 7404 Mission Street to 83 First Street for The Bar Downtown, LLC dba The Bar Downtown; and,

WHEREAS, The Planning Department has verified that the area is properly zoned; and,

WHEREAS, The Police Department recommends that the liquor license application be approved with conditions; now, therefore, be it

RESOLVED, That in accordance with Section 23958.4 of the California Business and Professions Code, the Board of Supervisors of the City and County of San Francisco hereby determines for the foregoing reasons that the transfer of a Type 48 on-sale general public premises license from 7404 Mission Street to 83 First Street to Mark E. Rennie for The Bar Downtown, LLC dba The Bar Downtown, will serve the public convenience and necessity of the people of the City and County of San Francisco.

Conditions: (1) The sale, service, and consumption of alcoholic beverages shall be permitted only between the hours of 10:00 a.m. and 12:00 midnight Sunday through

Tuesday and 10:00 a.m. to 2:00 a.m. on Wednesday through Saturday, and 10:00 a.m. to 2:00 a.m. – New Year's Eve, Christmas Eve, Thanksgiving Eve, the Fourth of July, and the Sunday before Labor Day and Memorial Day. (2) No reduced price alcoholic beverage promotion shall be allowed. (3) There shall be no coin operated games or video machines maintained upon the premises at any time. (4) No noise shall be audible beyond the area under control of the licensee(s) as defined on the ABC-257 dated 10/11/2006. (5) No person under the age of twenty-one (21 years of age) shall sell, furnish, or deliver alcoholic beverages. (6) The sale of alcoholic beverages for consumption off the premises is strictly prohibited. (7) Petitioner shall not permit its patrons or the general public to loiter or congregate on the sidewalks adjacent to the licensed premises. The orderly standing of patrons in line to enter the premises shall not be considered loitering or unlawfully congregating. (8) The petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control. (9) At any time the premises are providing live entertainment, the petitioner(s) shall provide security personnel that shall maintain order therein and prevent any activity which would interfere with the quiet enjoyment of their property by nearby residents. Said personnel shall be clothed in such a manner as to be readily identifiable as security. (10) Petitioner shall not make structural changes in the premises interior without prior written approval from the Department. (11) The interior lighting maintained therein shall be sufficient to make easily discernible the appearance and conduct of all persons and patrons in that portion of the premises where alcoholic beverages are sold, served, delivered or consumed. (12) The exterior of the premises shall be equipped with lighting of sufficient power to illuminate and make easily discernible the appearance and conduct of all persons on or about the premises. Additionally, the position of such lighting shall not disturb the normal privacy and use of

any neighboring residences. (13) At no time shall any person under the age of 21 years enter or remain in this public premises.
