3 Resolution urging the California State Legislature to uphold the public's right to access  
4 misconduct information about public employees by supporting legislation to overturn the  
5 *Copley* Decision.

7 WHEREAS, The City and County of San Francisco has consistently supported civilian  
8 oversight of the Police Department; and,

9 WHEREAS, The Police Commission has had a practice of holding public hearings  
10 regarding police misconduct complaints; and,

11 WHEREAS, Openness and transparency in law enforcement engender better police  
12 community relations and lead to a more accountable and effective police department; and,

13 WHEREAS, The California Supreme Court issued an opinion in *Copley Press v.*  
14 *Superior Court* last August that held records of police conduct cases heard by the San Diego  
15 Civil Service Commission were confidential records of the San Diego Police Commission;  
16 and,

17 WHEREAS, The *Copley* decision has had the effect of closing down police oversight  
18 hearings across the state including the hearings and records of the San Francisco Police  
19 Commission; and,

20 WHEREAS, The public has a right of access to misconduct information about other  
21 public employees; and,

22 WHEREAS, The effects of the *Copley* decision has been to reduce openness and  
23 transparency and create a level of secrecy in police records that is greater than that of most  
24 other states; and,
