4 **Administrative Code Section 1.56, to expend funds to print 50 copies its fiscal year**

7 WHEREAS, The San Francisco Department of Building Inspection, whose mission is to  
8 oversee the effective, efficient, fair, and safe enforcement of City building, housing, plumbing,  
9 electrical, mechanical, and disability access codes, produces an Annual Report as one of its  
10 community and public outreach communications' tools; and,

11 WHEREAS, The Department is implementing online access to its important public  
12 documents through its web site at [www.sfgov.org/dbi](http://www.sfgov.org/dbi), including its Annual Reports; and,

13 WHEREAS, Even though increasing numbers of people are taking advantage of  
14 today's online access technologies, the Department continues to receive requests for printed  
15 copies of its Annual Report from international visitors and public officials from cities across the  
16 United States and around the world, as well as from other building industry-related  
17 organizations and businesses, neighborhood and community organizations, and permit  
18 applicants; and,

19 WHEREAS, In an effort to meet these requests for printed copies of the Department's  
20 Annual Reports, the Department, in accordance with Administrative Code Section 1.56(d),  
21 requests permission from the Board of Supervisors to authorize the Department to expend  
22 funds to print 50 copies of last year's Report (2005/06) and 50 copies of the fiscal year  
23 2006/07 Report, and,

24 WHEREAS, On March 28, 2007, the Director of the Department submitted a letter to  
25 the Clerk of the Board of Supervisors that explained the need to print these Reports and the

1 project costs of printing in accordance with Administrative Code Section 1.56(d). A copy of  
2 this letter is on file with the Clerk of the Board of Supervisors in File No. 070421 and  
3 is incorporated herein by reference; now, therefore be it

4       RESOLVED, That the San Francisco Board of Supervisors in accordance with  
5 Administrative Code Section 1.56 does hereby grant permission to the Department of Building  
6 Inspection to expend funds to print the requested number of copies of its Annual Reports for  
7 the current fiscal year and for the immediately preceding fiscal year.
