3 **Resolution accepting a gift of airfare, accommodations and conference fees valued in**
4 **an amount of \$16,800 from the San Francisco Chamber of Commerce for four City**
5 **officials or employees to join the Chamber on its 2007 CityTrip to Boston.**

7 WHEREAS, The San Francisco Chamber of Commerce, located at 235 Montgomery
8 Street, San Francisco, CA 94104, (415) 392-4520, is a non-profit organization established to
9 attract, develop and retain businesses in San Francisco and has no financial interests
10 involving the City and County of San Francisco; and

11 WHEREAS, The Chamber undertakes an annual CityTrip to bring together public and
12 private leaders to help shape and advance San Francisco's regional competitive advantage
13 by visiting other cities that can teach these leaders something about the issues most critical to
14 the City's development; and

15 WHEREAS, The Chamber has selected the City of Boston for its 2007 CityTrip in order
16 to learn more about what is being done in that City in the areas of regionalized transportation
17 upgrades; revitalization of the waterfront and urban infill development; economic development
18 and job creation; and enhancing access to health care and reform of public education; and,

19 WHEREAS, The Chamber has offered in letters on file with the Clerk of the Board of
20 Supervisors in File No. 070641 which are hereby declared to be a part of this resolution as if
21 set forth fully herein, to make an in-kind contribution, in the amount of \$16,800, to the City &
22 County of San Francisco to cover the cost of airfare, accommodations and conference fees
23 for four City officials or employees to join the Chamber's delegation to Boston; and,

1 WHEREAS, The City and County of San Francisco wishes to accept this gift so that its
2 leaders are better informed on how other jurisdictions are addressing these important issues;

4 WHEREAS, The Board of Supervisors previously approved the acceptance of this
5 same gift by resolution in File No. 070551 on at the meeting of 5/1/07, now, therefore, be it

6 RESOLVED, That in accordance with Administrative Code sections 10.100-305 and
7 67.29-6 and section 18944.2 of Title Two of the California Code of Regulations, the Board of
8 Supervisors authorizes the acceptance of this gift on behalf of the City and County of San
9 Francisco; and, be it

10 FURTHER RESOLVED, That the City in its sole discretion has determined that four
11 City officials or employees shall use this gift; and, be it

12 FURTHER RESOLVED, That these officials and employees shall use this gift for the
13 official City purpose of gathering information on the important issues mentioned above; and,
14 be it

15 FURTHER RESOLVED, That this Resolution supercedes File No. 070551.
