3 **Resolution authorizing the Planning Department to apply for a Workforce Housing**  
4 **Reward Program Grant.**

6 WHEREAS, The State of California, Department of Housing and Community  
7 Development (the "HCD") has issued a Notice of Funding Availability dated April 2006 (the  
8 "NOFA") under its Workforce Housing Reward (WFH) Program; and  
9

10 WHEREAS, The Planning Department of the City and County of San Francisco (the  
11 "Planning Department"), desires to apply for a WFH grant and submit the Application Package  
12 released December 2006 by the HCD for the WFH Program; and,

13 WHEREAS, The HCD is authorized to approve funding allocations for the WFH  
14 Program, subject to the terms and conditions of the NOFA, Program Guidelines, Application  
15 Package, and Standard Agreement; now, therefore, be it

16 RESOLVED, That the Planning Department is hereby authorized and directed to apply  
17 for and submit to the HCD the Application Package released December 2006 by HCD for the  
18 WFH Program. If the application is approved, the Planning Department is hereby authorized  
19 and directed to enter into, execute, and deliver a State of California Standard Agreement (the  
20 "Standard Agreement"), and any and all other documents required or deemed necessary or  
21 appropriate to secure a WFH Grant from the HCD, and all amendments thereto (collectively,  
22 the "WFH Grant Documents"); and, be it

23 FURTHER RESOLVED, That the Planning Department shall be subject to the terms  
24 and conditions as specified in the Standard Agreement. Funds are to be used for allowable  
25 capital asset project expenditures to be identified in Exhibit A of the Standard Agreement.

1 The application in full is incorporated as part of the Standard Agreement. Any and all  
2 activities funded, information provided, and timelines represented in the application are  
3 enforceable through the Standard Agreement. The Planning Department hereby agrees to  
4 use the funds for eligible capital asset(s) in the manner presented in the application as  
5 approved by the HCD and in accordance with the NOFA and Program Guidelines and  
6 Application Package; and, be it

7 FURTHER RESOLVED, That the Director of the Planning Department is authorized to  
8 execute in the name of the Planning Department the Application Package and the WFH Grant  
9 Documents as required by the HCD for participation in the WFH Program.
