3 Resolution authorizing the Department of the Environment to apply for, accept and
4 expend grant funds, available only for public agencies in California, in the amount of
5 \$361,553 from the California Air Resources Board (CARB) for the purpose of
6 purchasing low-polluting construction equipment and retrofitting existing construction
7 equipment with pollution control devices.

9 WHEREAS, In accordance with the 2006-2007 Budget Bill AB 1801, Chapter 47,
10 Statutes of 2006, \$25 million originally allocated for the replacement of older school buses is
11 to be redirected as grants to public agencies to purchase low-polluting construction
12 equipment; and,

13 WHEREAS, The City and County of San Francisco is eligible to apply for these funds;
14 and,

15 WHEREAS, the Board of Supervisors has adopted the Sustainability Plan for the City
16 and County of San Francisco which states that "achieving and maintaining good air quality is
17 crucial to the public health and economic vitality of San Francisco"; and,

18 WHEREAS, Construction equipment emits significant quantities of toxic diesel
19 particulate matter and nitrogen oxides that form smog and particles in the atmosphere; and,

20 WHEREAS, the Board of Supervisors for the City and County of San Francisco
21 amended the Environment Code to add Section 411 to urge City departments with off-road
22 construction equipment to apply for funding to retrofit or replace such equipment; and,

23 WHEREAS, replacing and retrofitting the engines of the construction equipment will
24 result in reduced diesel emissions within the City and County of San Francisco; and,

1 WHEREAS, the San Francisco Bay Area is second in the state only to the Los Angeles
2 area in health and economic damage from construction equipment emissions according to the
3 Union of Concerned Scientists; and,

4 WHEREAS, funds from this grant will be used to support city departments in
5 performing actions they would need to be performing without grant funds, and;

6 WHEREAS, CARB does not allow indirect costs to be included in the grant; and,


7 WHEREAS, This grant does not require an ASO amendment; and,

8 WHEREAS, An accept and expend resolution is required in the event that these
9 projects are designated for CARB funding awards and the City must sign a contract for said
10 funds; and


11 WHEREAS, CARB must encumber the funds prior to June 30, 2007 or it will loose the
12 funds; and;

13 WHEREAS, CARB requires all applications to be authorized by the applicant's
14 governing board, or in this case, the Board of Supervisors, so that funds may be encumbered
15 prior to the June 30, 2007 date; now, therefore, be it

16 RESOLVED, That the Director of the Department of the Environment is authorized to
17 apply for, accept and expend \$361,553 funding from the California Air Resources Board.
