2 **Resolution authorizing the Director of Public Works or his or her designee to execute**  
3 **Master Agreements between the City and County of San Francisco, through its**  
4 **Department of Public Works, and the California Department of Transportation.**

6 WHEREAS, The Department of Public Works is eligible to receive federal and state  
7 funding for certain transportation projects through the California Department of Transportation  
8 (Caltrans); and,  
9

10 WHEREAS, Master Agreements and all Program Supplemental Agreements need to  
11 be executed with Caltrans before such funds may be claimed; and,

12 WHEREAS, Caltrans has revised its Master Agreements to reflect the enactment of the  
13 Safe, Accountable, Flexible, Efficient, Transportation Equity Act – A Legacy for users  
14 (SAFETEA-LU); and,

15 WHEREAS, The revised Master Agreements have no termination date; and,

16 WHEREAS, The Board of Supervisors must approve execution of agreements which  
17 exceed a ten-year period under Charter Section 9.118; and,

18 WHEREAS, The City and County of San Francisco wishes to authorize the Director of  
19 Public Works to execute Master Agreements and any amendments thereto between the City  
20 and County of San Francisco and Caltrans for state and federally funded transportation  
21 projects for the Department of Public Works; now therefore, be it

22 RESOLVED, That the San Francisco Board of Supervisors approves the execution of  
23 Master Agreements between the City and County of San Francisco, through its Department of  
24 Public Works, and Caltrans, and authorizes the Director of Public Works or his or her

1 designee to execute Master Agreements and any amendments thereto with Caltrans on its  
2 behalf.
