

1 **[Approval of a 60 day extension for Planning Commission review.]**

4 **Resolution extending by 60 days the prescribed time within which the Planning**  
5 **Commission may render its decision on a proposed ordinance that would amend the**  
6 **Planning Code regarding institutional master plan review for medical institutions.**

8 WHEREAS, On May 15, 2007, Supervisor Maxwell introduced legislation to initiate the  
9 process amending San Francisco Planning Code Section 304.5, Institutional Master Plans, to  
10 require a qualified health planner retained by the Department of Public Health to analyze the  
11 relationship to between the City's long-termcitywide health care needs of and facility planning  
12 for medical institutions; specificallys' concurrent with institutional master plans and their ,  
13 revisions, and as well as conditional use applications filed by medical institutions;, to provide  
14 comments to the Planning Department and, making environmental findings, and making  
15 findings of consistency with the General Plan and priority policies of Planning Code Section  
16 101.1. A copy of said legislation is on file with the Clerk of the Board of Supervisors in File  
17 No. 070678 and is incorporated herein by reference; and,

19 WHEREAS, On or about May 23, 2007, the Clerk of the Board of Supervisors referred the  
20 proposed ordinance to the Planning Commission, which currently is reviewing the proposed  
21 ordinance; and,

23 WHEREAS, The Board, in accordance with Planning Code Section 306.4(d) may, by  
24 resolution, extend the prescribed time within which the Planning Commission is to render its

1 decision on proposed amendments to the Planning Code that the Board of Supervisors  
2 initiates; and,

4 WHEREAS, The Planning Department has requested additional time to review the proposed  
5 ordinance; and,

7 WHEREAS, The Board deems it appropriate in this instance to grant to the Planning  
8 Commission additional time to review the proposed ordinance and render its decision; now,  
9 RESOLVED, That by this resolution, the Board hereby extends the prescribed time within which  
10 the Planning Commission may render its decision on the proposed ordinance for an additional 60  
11 days.
