3 **Resolution appointing Jazzie Collins, Ada Chan, and Angelica Cabande, terms ending**
4 **April 27, 2009, to the SOMA Community Stabilization Fund Community Advisory**
5 **Committee, San Francisco elector requirement waived.**

7 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
8 does hereby appoint the hereinafter designated persons to serve as members of the SOMA
9 Community Stabilization Fund Community Advisory Committee, pursuant to the provisions of
10 Planning Code Section 318 and Ordinance No. 217-05, for the terms specified:

11 Jazzie Collins, succeeding herself, term expired, seat 3, must be a senior or disabled
12 resident of SOMA, for the unexpired portion of a two-year term ending April 27, 2009.

13 Ada Chan (San Francisco elector requirement waived), succeeding herself, term
14 expired, seat 4, must have affordable housing expertise and familiarity with the SOMA
15 neighborhood, for the unexpired portion of a two-year term ending April 27, 2009.

16 Angelica Cabande (San Francisco elector requirement waived), succeeding Donald
17 Frazier, resigned, seat 5, must represent a community-based organization in SOMA, for the
18 unexpired portion of a two-year term ending April 27, 2009; and, be it

19 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 20 1. The membership of the SOMA Community Stabilization Fund Community Advisory
21 Committee has a goal to be representative of the diversity of the City and County of
22 San Francisco.
- 23 2. Applicants Ada Chan, an appointee, and Angelica Cabande, a new appointee, who
24 are not electors of San Francisco, are persons with experience that uniquely

1 qualifies them to serve on the SOMA Community Stabilization Fund Community
2 Advisory Committee.

3 3. The SOMA Community Stabilization Fund Community Advisory Committee has
4 attempted to fill the positions, for which Ada Chan and Angelica Cabande were
5 nominated, with individuals who are City electors and who have the specific
6 experience, skills, and qualifications, but has been unable to do so at this time. The
7 Rules Committee has certified that Ada Chan and Angelica Cabande are qualified
8 to serve on the SOMA Community Stabilization Fund Community Advisory
9 Committee.

10 4. After exercising due diligence, the Board of Supervisors concludes that there are no
11 other possible representatives, who are electors of San Francisco and who have
12 the specific experience, skills, or qualifications possessed by these applicants, and
13 who is willing to serve on the SOMA Community Stabilization Fund Community
14 Advisory Committee at this time; and, be it

15 FURTHER RESOLVED, That the Board of Supervisors waives the requirement for Ada
16 Chan and Angelica Cabande, as allowed in cases where no qualified City electors, willing to
17 serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s)
18 appointed to boards, commissions, and advisory bodies established by legislative act of the
19 Board of Supervisors to be electors of the City and County of San Francisco.




