3 **Resolution authorizing the Airport Commission to accept and expend a grant of**  
4 **\$609,711 from the Bay Area Air Quality Management District (Air District), and a**  
5 **matching grant of \$500,000 from the California Department of Transportation for the**  
6 **retrofit of diesel buses by Airport transportation operators.**

8 WHEREAS, Pursuant to its Clean Vehicle Policy, the Airport seeks to reduce vehicle  
9 emissions in the region and on terminal roadways; and

10 WHEREAS, The Air District assists public agencies in implementing vehicle emissions  
11 reduction projects; and,

12 WHEREAS, The Airport Commission in Resolutions 06-0026 and 07-0101 approved  
13 seeking, accepting, and expending funds for clean air vehicles; and

14 WHEREAS, The Airport would administer the subject grants, disburse incentive funds  
15 to airport transportation operators, and provide the Air District with information concerning the  
16 retrofitted vehicles; and

17 WHEREAS, No Airport or City funds would be used for this program; and

18 WHEREAS, This project would continue the Airport's leadership role in promoting  
19 emissions reduction by transportation providers; and

20 WHEREAS, The grant does not require an ASO amendment; and

21 WHEREAS, The Airport proposes to maximize use of available grant funds on program  
22 expenditures by not including indirect costs in the grant budget; now, therefore, be it


23 **RESOLVED**, That, pursuant to San Francisco Administrative Code §10.171, the Board


