3 **Resolution enacting and rescinding parking regulations on Clementina Street.**

5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
6 and the San Francisco Traffic Code, the following regulations governing the parking of
7 vehicles are hereby enacted or rescinded as designated below:
8

9 **RESIDENTIAL PERMIT PARKING AREA "Y" (2-HOUR TIME LIMIT, 9 AM TO 6 PM,
10 EVERYDAY) - ESTABLISH**

11 Clementina Street, both sides, between 1st and 2nd Streets (unit block, includes
12 addresses on both sides for permits, but signs will only be installed on the south
13 side); and,

14 246 Second Street (no signs will be installed on 2nd Street, but residents will be eligible
15 for Area "Y" permits).

16 **PARKING METER AREA NO. 1 (1-HOUR PARKING TIME LIMIT, 7 AM TO 6 PM, MONDAY
17 THROUGH SATURDAY) - RESCIND**

18 ~~Clementina Street, south side, between 1st and 2nd Streets (meters have been
19 legislated, but have not been installed).~~

20 Categorically exempt from Environmental Review
21 Class 1(c)(9) changes in the traffic and parking
22 regulations where such changes do not establish a
23 higher speed limit or result in more than a negligible
24 increase in the use of the street.


