9 WHEREAS, John Kyoyoon Lee is seeking transfer of a Type 21 off-sale general  
10 license for Fillmore Market located at 1641 Fillmore Street; and,

11 WHEREAS, The Planning Department has verified that the area is properly  
12 zoned; and,

13 WHEREAS, The Police Department recommends that the liquor license  
14 application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business  
16 and Professions Code, the Board of Supervisors of the City and County of San  
17 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21  
18 off-sale general license from 1669 Fillmore Street to 1641 Fillmore Street for John  
19 Kyoyoon Lee dba Fillmore Market, will serve the public convenience and necessity of  
20 the people of the City and County of San Francisco.

21 Conditions: (1) Sales and service of alcoholic beverages shall be permitted only  
22 between the hours of 8:00 a.m. and 2:00 a.m. each day of the week. (2) The  
23 petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the  
24 premises over which they have control. (3) No more than thirty-three percent of the  
25 premises square footage shall be devoted to the sale and display of alcoholic

1 beverages. (4) The petitioner(s) shall not permit their patrons or the general public to  
2 loiter or congregate on the area adjacent to the licensed premises.


