

1 [Approval of the Ryan White HIV/AIDS Treatment Modernization Act grant application.]

3 **Resolution authorizing the San Francisco Department of Public Health (DPH) to submit**  
4 **an application by the deadline of November 5, 2007, to the Health Resources Services**  
5 **Administration (HRSA) to continue to receive funding for the Ryan White HIV/AIDS**  
6 **Treatment Modernization Act Grant (Ryan White Programs, Part A); for the next grant**  
7 **year, March 1, 2008 through February 28, 2009, with an expected amount of**  
8 **approximately \$36,118,233 in funding for the San Francisco Eligible Metropolitan Area**  
9 **(EMA).**

11 WHEREAS, The San Francisco Board of Supervisors passed Ordinance No. 265-05 in  
12 November 2005, amending Section 10-170 of the Administrative Code to require Board  
13 review of proposed annual or otherwise recurring grant applications of \$5,000,000 or more  
14 prior to their submission; and,

15 WHEREAS, DPH is currently a recipient of this annual, recurring grant, known as Ryan  
16 White Programs, Part A, from HRSA for the funding period of March 1, 2007 through February  
17 28, 2008 in the amount of \$18,806,853 for the San Francisco Eligible Metropolitan Area  
18 (EMA) which includes the City and County of San Francisco, Marin County and San Mateo  
19 County; and,


20 WHEREAS, DPH uses these funds to cover a multitude of health services to HIV  
21 positive persons residing in the three counties within the San Francisco EMA; and,

22 WHEREAS, DPH was unable to submit a resolution to the Board of Supervisors for  
23 approval 60 days in advance of the application due date, as required by Ordinance No. 265-  
24 05, because HRSA did not send the application guidance until September 11, 2007; and,

1           WHEREAS, in the interest of timeliness, DPH is making this request for approval by  
2 submitting last year's application to HRSA for the Ryan White Programs, Part A grant, also  
3 including supporting documents as required by Ordinance No. 265-05 and it is on file with the  
4 Clerk of the Board of Supervisors in File No. 071418, which is hereby declared to  
5 be a part of the Resolution as if set forth fully herein; and, now, therefore, be it

6           RESOLVED, That the Board of Supervisors hereby approves DPH's application for the  
7 Ryan White Programs, Part A grant for the funding period of March 1, 2008 through February  
8 28, 2009, to be submitted no later than November 5, 2007.


