3 **Resolution appointing Natalie Brutto, term ending December 31, 2009, and Noushin**
4 **Mofakham, term ending December 31, 2010, to the Child Care Planning and Advisory**
5 **Council; residency requirement waived.**

7 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
8 does hereby appoint the hereinafter designated person to serve as a member of the Child
9 Care Planning and Advisory Council, pursuant to the provisions of the San Francisco
10 Administrative Code, Section 5.200, and California Education Code, Sections 8499-8499.8,
11 for the term specified:

12 Natalie Brutto, succeeding herself, term expired, seat 5, must be a nominee of District
13 5 Supervisor selected from: parent advisory councils of public and private child care
14 programs; associations of child care centers, family day care providers and Head Start; public
15 interest organizations including but not limited to the Child Care Law Center; community
16 organizations; the Bay Area Employer Work and Family Coalition; and members of labor
17 organizations and local organizations that fall within the definition of "Community
18 representative," for the unexpired portion of a three-year term ending December 31, 2009.

19 Noushin Mofakham (residency requirement waived), succeeding Chris Cleary, term
20 expired, seat 6, must be a nominee of District 6 Supervisor selected from: parent advisory
21 councils of public and private child care programs; associations of child care centers, family
22 day care providers and Head Start; public interest organizations including but not limited to
23 the Child Care Law Center; community organizations; the Bay Area Employer Work and
24 Family Coalition; and members of labor organizations and local organizations that fall within

1 the definition of "Community representative," for a new three-year term ending December 31,
2 2010; and, be it

3 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 4 1. The membership of the Child Care Planning and Advisory Council has a goal to be
5 representative of the diversity of the City and County of San Francisco.
- 6 2. Applicant Noushin Mofakham, a new appointee who is not a resident of San
7 Francisco, is a person with experience that uniquely qualifies her to serve on the
8 Child Care Planning and Advisory Council.
- 9 3. The Child Care Planning and Advisory Council has attempted to fill the position, for
10 which Noushin Mofakham was nominated, with an individual who is a City resident
11 and who has the specific experience, skills, and qualifications, but has been unable
12 to do so at this time. The Rules Committee has certified that Noushin Mofakham is
13 qualified to serve on the Child Care Planning and Advisory Council.
- 14 4. After exercising due diligence, the Board of Supervisors concludes that there is no
15 other possible representative, who is a resident of San Francisco and who has the
16 specific experience, skills, or qualifications possessed by this applicant, and who is
17 willing to serve on the Child Care Planning and Advisory Council at this time; and,
18 be it

19 FURTHER RESOLVED, That the Board of Supervisors waives the residency
20 requirement for Noushin Mofakham, as allowed in cases where no qualified City resident,
21 willing to serve, can be found, pursuant to Section 4.101 of the City Charter that requires
22 person(s) appointed to boards, commissions, and advisory bodies established by legislative
23 act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.
