2 International Airport.]

4 **Resolution approving and authorizing the execution of Lease No. GS-09B-02006 with**
5 **the United States of America for office space to be occupied by the Transportation**
6 **Security Administration, a Federal agency, in the International Terminal of San**
7 **Francisco International Airport.**

8 WHEREAS, on November 19, 2001, the Federal government passed the Aviation and
9 Transportation Security Act, thereby creating the Transportation Security Administration
10 ("TSA"); and

11 WHEREAS, the TSA is responsible for ensuring aviation security at all U.S. airports,
12 including San Francisco International Airport (the "Airport"); and

13 WHEREAS, the TSA currently occupies office space in the International Terminal of the
14 Airport under Lease No. GS-09B-01526 pursuant to Airport Commission Resolution No. 03-
15 0126, adopted on June 25, 2003 and Board of Supervisors' Resolution No. 543-03, adopted
16 on August 22, 2003; and

17 WHEREAS, the aforementioned lease terminates on October 31, 2007 and the TSA
18 wishes to enter into a new lease with a term of five (5) years effective November 1, 2007; and

19 WHEREAS, Airport staff has negotiated a renewal lease with the United States of
20 America for 7,200 square feet of office space, to be occupied by the TSA, with a term of five
21 (5) years; and

22 WHEREAS, on August 21, 2007, pursuant to Resolution No. 07-0195, the Airport
23 Commission approved Lease No. GS-09B-02006 (the "Lease") with the United States of
24 America; and

25 WHEREAS, a copy of the form of the Lease is on file with the Clerk of the Board of
Supervisors in File No. 071461, which is hereby declared to be a part of this resolution as
if set forth fully herein; now, therefore, be it

1 RESOLVED, that this Board of Supervisors hereby approves and authorizes the
2 execution of Lease No. GS-09B-02006 for space in the International Terminal of the Airport,
3 retroactive to November 1, 2007, between the United States of America, and the City and
4 County of San Francisco, acting by and through its Airport Commission.


