3 **Resolution authorizing the Department of Emergency Management, Division of**
4 **Emergency Services, to accept and expend a Federal pass through grant in the amount**
5 **of \$1,723,887 from the Governor's Office of Homeland Security for three grant**
6 **programs: the State Homeland Security Program (SHSP), the Law Enforcement**
7 **Terrorism Prevention Program (LETPP), and the Metropolitan Medical Response**
8 **System (MMRS).**

10 WHEREAS, On July 18, 2007 the United States Department of Homeland Security
11 (DHS) announced final award allocations for the FY 07 Homeland Security Grant Program
12 (HSGP) totaling approximately \$1.7 billion to States, Territories, and Urban Areas; and,

13 WHEREAS, The 2007 Homeland Security Grant Program continues to provide funding
14 to prevent, protect against, respond to, and recover from terrorist attacks, major disasters, and
15 other emergencies; and,

16 WHEREAS, In recognition of the fact that funds must be expended wisely, subgrantees
17 must now utilize a risk and need-based allocation process as well as support the National
18 Preparedness Goal and National Priorities; and,

19 WHEREAS, San Francisco received \$947,271 in SHSP funds, \$518,471 in LETPP
20 funds, and \$258,145 in MMRS funds; and,

21 WHEREAS, Funds received must be expended no later than March 31, 2010; and,

22 WHEREAS, The grant does not require an ASO amendment; and,


23 WHEREAS, The grant does not include any provisions for indirect costs, indirect costs
24 are requested to be waived; now, therefore, be it

25 **RESOLVED, That the City and County of San Francisco hereby authorizes the**


