3 **Resolution determining that the issuance of a Type 42 on-sale beer and wine**
4 **public premises license to Kamran Shirazi for Lot 61 located at 1870 Fillmore**
5 **Street, will serve the public convenience and necessity of the people of the City**
6 **and County of San Francisco, in accordance with Section 23958.4 of the**
7 **California Business and Professions Code; with conditions.**

9 WHEREAS, **Kamran Shirazi** is seeking issuance of a **Type 42 on-sale beer**
10 **and wine public premises license** for Lot61 located at **1870 Fillmore Street**; and,

11 WHEREAS, The Redevelopment Agency has verified that the area is properly
12 zoned; and,

13 WHEREAS, The Police Department recommends that the liquor license
14 application be approved with conditions: now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business
16 and Professions Code, the Board of Supervisors of the City and County of San
17 Francisco hereby determines for the foregoing reasons that the issuance of a Type 42
18 on-sale beer and wine public premises license, to Kamran Shirazi for Lot61, located at
19 1870 Fillmore Street will serve the public convenience and necessity of the people of
20 the City and County of San Francisco.

21 Conditions: (1) Sales, service and consumption of alcoholic beverages shall be
22 permitted only between the hours of 11:00 a.m. and 11:30 p.m. each day of the week.

23 (2) No noise shall be audible beyond the area under control of the licensee. (3) The
24 petitioner shall be responsible for maintaining free of litter the area adjacent to the
25 premises over which they have control. (4) Loitering (loitering is defined as "to stand

1 idly about, linger aimlessly without lawful business) is prohibited on any sidewalks or
2 property adjacent to the licensed premises under the control of the licensee. (5) The
3 sale of alcoholic beverages is strictly prohibited. (6) No person under the age of twenty-
4 one (21) years of age shall sell, furnish or deliver alcoholic beverages. (7) Graffiti shall
5 be removed from the premises and all parking lots under the control of the licensee
6 within 72 hours of application. If the graffiti occurs on a Friday or weekend day, or on a
7 holiday, the licensee shall remove the graffiti within 72 hours following the beginning of
8 the next weekday. (8) The interior lighting maintained therein shall be sufficient to make
9 easily discernible the appearance and conduct of all persons and patrons in that portion
10 of the premises where alcoholic beverages are sold, served, delivered or consumed.
