3 **Resolution authorizing the San Francisco Department of Public Health (DPH), to accept**
4 **and expend retroactively a grant in the amount of \$9,429.04 from the University of**
5 **California, San Francisco (UCSF), to provide technical assistance for the HIV**
6 **Prevention among High-Risk Men in South Africa (Gauteng MSM Study) to measure the**
7 **prevalence of HIV risk behaviors and HIV infection in Soweto, South Africa, for the**
8 **period of November 5, 2007 through April 30, 2008.**

10 WHEREAS, UCSF has agreed to reimburse DPH in the amount of \$9,429.04 under the
11 term of an agreement for the period of November 5, 2007 through April 30, 2008 to support
12 the HIV Prevention among High-Risk Men in South Africa (Gauteng MSM Study); and,

13 WHEREAS, As a condition of receiving the funds UCSF requires DPH to enter into an
14 agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of
15 Supervisors in File No. 071628, which is hereby declared to be a part of this resolution as if
16 set forth fully within; and,

17 WHEREAS, The grant does not require an ASO amendment and partially reimburses
18 the department for an existing position, Health Program Coordinator III (Job Class #2593) at
19 .05 FTE for the period of November 5, 2007 through April 30, 2008; and,

20 WHEREAS, A request for retroactive approval is being sought because the final
21 agreement was not obtained by DPH until November 13, 2007; and,

22 WHEREAS, The budget includes provision for indirect costs of \$1,010; now therefore,

3 Study;" and, be it


4 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and

8 agreement on behalf of the City; and, be it


9 FURTHER RESOLVED, That the Controller is directed to designate all positions


