3 **Resolution determining that the issuance of a Type 40 on-sale beer license to**  
4 **John Casimier Mitchell for Fat Beli Deli located at 2598 San Bruno Avenue**  
5 **(District 10), will serve the public convenience and necessity of the people of the**  
6 **City and County of San Francisco, in accordance with Section 23958.4 of the**  
7 **California Business and Professions Code; with conditions**

9 WHEREAS, John Casimier Mitchell for Fat Beli Deli is seeking issuance of a  
10 Type 40 on-sale beer license for Fat Beli Deli, located at 2598 San Bruno Avenue; and,

11 WHEREAS, The Planning Department has verified that the area is properly  
12 zoned; and,

13 WHEREAS, The Police Department recommends that the liquor license  
14 application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business  
16 and Professions Code, the Board of Supervisors of the City and County of San  
17 Francisco hereby determines for the foregoing reasons that the issuance of a Type 40  
18 on-sale beer license, to John Casimier Mitchell for Fat Beli Deli for, located at 2598 San  
19 Bruno Avenue will serve the public convenience and necessity of the people of the City  
20 and County of San Francisco.

21 Conditions: (1) Sales, service, and consumption of alcoholic beverages shall be  
22 permitted only between the hours of 9:00 a.m. and 7:00 p.m. each day of the week.

23 (2) Not more than 15% of the square footage of the premises will be used for the sale,  
24 service and/or consumption of alcoholic beverages. (3) No noise shall be audible  
25 beyond the area under the control of the licensee(s). (4) The petitioner shall not permit

1 their patrons or the general public to loiter or congregate on the area adjacent to the  
2 license premises. (5) The petitioner shall be responsible for maintaining free of litter  
3 the area adjacent to the premises over which they have control. (6) Graffiti shall be  
4 removed from the premises and all parking lots under the control of the licensee within  
5 72 hours of application. If the graffiti occurs on a Friday or weekend day, or on a  
6 holiday, the licensee shall remove the graffiti with 72 hours following the beginning of  
7 the next weekday. (7) The sale of alcoholic beverages for consumption off the premises  
8 is strictly prohibited.
