19 the boards of directors of the Bay Trail Project and Friends of the Estuary, as the  
20 Commission's representative on the Management committee of the San Francisco Estuary  
21 Project, and the Commission's alternate representative on the Shell Oil Spill Litigation  
22 Settlement Trustee Committee; and
