

1 [Extending Deadline for the Annual Report on Community Safety Cameras.]

3 **Resolution approving an extension on the deadline for the annual report to the Board**
4 **of Supervisors on all community safety cameras located in the City and County of San**
5 **Francisco from January 17, 2008 to March 20, 2008, one year from the date of**
6 **installation of the cameras.**

8 WHEREAS, The Board of Supervisors added Chapter 19 to the San Francisco
9 Administrative Code, also known as the Community Safety Camera Ordinance; and

10 WHEREAS, The Community Safety Camera Ordinance mandates an annual report to
11 the Board of Supervisors and the Police Commission regarding the efficacy of all community
12 safety cameras located in the City and County of San Francisco; and,

13 WHEREAS, The Community Safety Ordinance mandates the report be issued one year
14 from approval of camera installation; and,

15 WHEREAS, The Police Commission indicated an intent to have a full year of data on
16 the efficacy of the community safety cameras from the date of initial operation; and,

17 WHEREAS, The installation of the community safety cameras in fact occurred in March
18 2007; and,

19 WHEREAS, The Center for Information Technology Research in the Interest of Society
20 at U.C. Berkeley is performing a study on the efficacy of the surveillance cameras that will
21 assist production of the annual report by March 20, 2008; now, therefore, be it

22 **RESOLVED**, That the Police Department, in conjunction with the City Administrator,
23 shall issue the annual report to the Board of Supervisors and Police Commission one year
24 following the date of the first camera installation and not less often than once yearly
25 thereafter; and, be it

1 FURTHER RESOLVED, That annual report shall include information regarding
2 necessary oversight as well as recommended improvements to the community safety camera
3 program.
