3 **RESOLUTION ACCEPTING AND EXPENDING A GIFT OF \$16,000 FROM THE FRIENDS**
4 **OF NOE COURTS VIA THE PARKS TRUST TO THE RECREATION AND PARK**
5 **DEPARTMENT FOR THE PLAY AREA AT NOE VALLEY TENNIS COURTS .**

7 WHEREAS, The City owns real property located in Noe Valley on Block 2829, Lot 1
8 known as "Noe Valley Tennis Courts" ("Noe Courts"); and,

9 WHEREAS, The Recreation and Park Commission approved a conceptual renovation
10 plan for the play area ("Play Area") at Noe Courts on June 15, 2006, under Resolution No.
11 0705-006; and,

12 WHEREAS, The Friends of Noe Courts is a park advocacy group, and Parks Trust is a
13 non-profit organization acting as fiscal sponsor for the Friends of Noe Courts; and,

14 WHEREAS, The Friends of Noe Courts through Parks Trust is proposing to fund the
15 purchase and installation of a picnic table and two benches at the Play Area with a monetary
16 gift of \$16,000 ("Gift") to the City and County of San Francisco; and,

17 WHEREAS, On November 2, 2007, under Commission Resolution No. 0711-004, the
18 Recreation and Park Commission recommends to the Board of Supervisors to accept and
19 expend the Gift; now, therefore, be it

20 **RESOLVED**, That the Board of Supervisors authorizes the General Manager of the
21 Recreation and Park Department to accept and expend the Gift of \$16,000 from the The
22 Friends of Noe Courts through Parks Trust for the play area at Noe Courts.


