3 **Resolution authorizing the Airport Commission to accept and expend two (2) grants**  
4 **totaling \$298,000 from the Bay Area Air Quality Management District (Air District) for**  
5 **acquisition of clean air vehicles by Airport transportation operators.**

7 WHEREAS, Pursuant to its Clean Vehicle Policy, the Airport seeks to reduce vehicle  
8 emissions in the region and on terminal roadways; and

9 WHEREAS, The Air District assists public agencies in implementing emissions  
10 reduction projects, such as the addition of clean air vehicles to fleets; and,

11 WHEREAS, The Airport Commission in Resolutions 06-0026 and 06-0203 approved  
12 seeking, accepting, and expending Air District funds for clean air vehicles; and

13 WHEREAS, Grant 06VIP28 provides \$100,000 for 25 natural gas-powered taxis and  
14 vans, and Grant 06R32 provides \$198,000 for 14 natural gas-powered hotel, parking, and  
15 airline crew minibuses; and

16 WHEREAS, The Airport would administer this grant, disburse incentive funds to airport  
17 transportation operators, and provide the Air District with information concerning the new  
18 vehicles; and

19 WHEREAS, The grant does not require ASO amendment; and,

20 WHEREAS, No Airport or City funds would be used for this program; and

21 WHEREAS, This demonstration project would continue the Airport's leadership role in  
22 promoting clean fuel use among transportation providers; and


23 WHEREAS, The Airport proposes to maximize use of available grant funds on program  
24 expenditures by not including indirect costs in the grant budget; now, therefore, be it

FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget.


