

1 [Gift of Funds to Office of Labor Standards Enforcement.]

3 **Resolution authorizing the Office of Labor Standards Enforcement to accept and**  
4 **expend a gift in the amount of \$33,892.65 pursuant to the settlement agreement in**  
5 **Aubrey et al. v. Marriott International, Inc. et al. for the purpose of enforcement of the**  
6 **San Francisco Minimum Wage.**

8 WHEREAS, In November 2003, San Francisco voters adopted the San Francisco  
9 Minimum Wage Ordinance, now codified as Section 12R of the San Francisco Administrative  
10 Code; and,

11 WHEREAS, The Office of Labor Standards Enforcement (OLSE) is designated in the  
12 Minimum Wage Ordinance as the city agency tasked with implementation and enforcement of  
13 the law; and,

14 WHEREAS, The Minimum Wage Ordinance provides for civil enforcement of the law in  
15 a court of competent jurisdiction; and,

16 WHEREAS, On September 26, 2005 workers filed a claim against Marriott Corporation  
17 ("Aubrey et al. v. Marriott International, Inc. et al." Case No. CGC-05-445159) in San  
18 Francisco Superior Court alleging violations of the Minimum Wage Ordinance; and,

19 WHEREAS, On May 9, 2007 the San Francisco Superior Court accepted judgment of a  
20 settlement agreement between the parties, a copy of which is on file with the Clerk of the  
21 Board of Supervisors in File No. 080384 and is incorporated herein by reference; and,

22 WHEREAS, Section V(F) ("Charity") of the settlement agreement provides for a gift of  
23 funds to OLSE of "all Payments that Marriott has been unable to make to members of the  
24 Settlement Class" despite diligent efforts; and,

1 WHEREAS, The settlement agreement stipulates that all funds gifted to OLSE "shall be  
2 specifically designated for the purpose of enforcement of the San Francisco Minimum Wage";  
3 and,


4 WHEREAS, Pursuant to Section V(F) of the settlement agreement, a gift of funds in the  
5 amount of \$33,892.65 was delivered to OLSE on October 15, 2007; now, therefore; be it

6 RESOLVED, That OLSE is hereby authorized to accept this gift in accordance with the  
7 requirements set forth pursuant to San Francisco Administrative Code Section 10.100-305;  
8 and, be it


9 FURTHER RESOLVED, That the Office of the Controller shall establish an account for  
10 the purpose of accepting this gift; and, be it


11 FURTHER RESOLVED, That the account established by the Office of the Controller  
12 shall restrict the use of these gifted funds to OLSE's enforcement of the Minimum Wage  
13 Ordinance.


