3 **Resolution approving the Eleventh Amendment to the Agreement between the City and**  
4 **County of San Francisco (Purchaser) and Sunset Scavenger Company (Contractor) for**  
5 **sludge hauling, extending the term of the contract by ~~one year to May 31, 2009~~ 11 months to**  
6 **April 30, 2009 and increasing the total compensation to the Contractor by \$3 million,**

9 WHEREAS, the Purchaser entered into an Agreement with Contractor dated  
10 December 6, 2001 for hauling of sludge, grit and other waste materials, as amended by the:

11 First Amendment, dated December 12, 2003,

12 Second Amendment, dated December 19, 2005,

13 Third Amendment, dated June 13, 2006,

14 Fourth Amendment, dated October 31, 2006,

15 Fifth Amendment, dated November 17, 2006,

16 Sixth Amendment, dated May 2, 2007,

17 Seventh Amendment, dated May 21, 2007,

18 Eighth Amendment, dated July 27, 2007,

19 Ninth Amendment, dated November 29, 2007, and

20 Tenth Amendment, dated February 14, 2008; and,

21 WHEREAS, the Purchaser and Contractor propose to enter into an Eleventh Amendment  
22 to extend the contract by ~~one year to May 31, 2009~~ eleven months to April 30, 2009 or sooner  
23 based on court action and/or notice of earlier termination date from the City, and to increase the  
24 total compensation from a not-to-exceed amount of \$13,615,000 to a not-to-exceed amount of  
25 \$16,615,000 and,




