3 **Resolution authorizing the San Francisco Department of Public Health (DPH), to**
4 **retroactively accept and expend funds from the California Department of Food and**
5 **Agriculture (CDFA) in the amount of \$66,325 in support of the High Risk (Pest**
6 **Exclusion) Program, for the period of July 1, 2007 through June 30, 2008.**

8 WHEREAS, DPH was awarded a grant from CDFA for the High Risk (Pest Exclusion)
9 Program for the period of July 1, 2007 through June 30, 2008 for \$66,325; and,

10 WHEREAS, The purpose of the High Risk (Pest Exclusion) Program is to prevent the
11 infestation of pests from incoming high risk shipments of plant material from Hawaii, Florida
12 and the other Southern states in the U.S.; and,

13 WHEREAS, As a condition of receiving the grant funds, CDFA requires the City to
14 enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the
15 Board of Supervisors in File No. 080575; which is hereby declared to be a part of
16 this resolution as if set forth fully herein; and,

17 WHEREAS, The grant budget includes a provision for indirect costs in the amount of
18 \$7,134.42; and,

19 WHEREAS, DPH received the contract from CDFA on March 24, 2008 with a start date
20 of July 1, 2007, hence the retroactive request; and,

21 WHEREAS, The grant does not require an ASO amendment and reimburses the
22 department for four existing positions, including two Agricultural Inspectors (Job Class #3450)
23 at .32 FTE; one Manager I/Agricultural Commissioner (Job Class #0922) at .05 FTE, and one
24 Jr. Administrative Analyst (Job Class #1820) at .02 FTE; now, therefore, be it
