10 WHEREAS, San Francisco County received an allocation of \$1,923,400 for Fiscal
11 Years 2006-07, 2007-08, and 2008-09; and,

12 WHEREAS, Section 5892 (a) (h) of the MHSA regulation specifies that the WET
13 component may be retained for up to ten years before reverting into the State fund ; and,

14 WHEREAS, The approval of the MHSA Agreement and the designation of the
15 Community Behavioral Health Director as the signatory of this agreement is on file with the
16 Clerk of the Board of Supervisors in File No. 080122, which is hereby declared to be a part of
17 this resolution as if set forth fully herein; and,

18 WHEREAS, DMH had approved our Request for Funding for Planning and Early
19 Implementation Activities for \$167,313, which will be taken out from our allocation, to begin
20 hiring consultants to develop the Request for Proposals and curricula development of the
21 ~~Mental Health Career Pathways Programs; now, therefore, be it~~

22 RESOLVED, That the WET Plan be approved by the Board of Supervisors; and, be it

23 FURTHER RESOLVED, That the Board of Supervisors authorize the amendment of
24 the MHSA Agreement to include the ~~WET Plan; and, be it~~
