17 WHEREAS, The State of California, through various homeland security grant  
18 programs, provides support for the development and maintenance of the capability of local  
19 jurisdictions to prepare for and respond to terrorist attacks using weapons of mass destruction  
20 and provides for the dispersal of federal funds provided for this purpose under Public law 110-  
21 161; and,

22 WHEREAS, The City and County of San Francisco has participated in these programs  
23 since their inception and deems participation in these programs as vital to the continued well  
24 being of its citizens; and,

1           WHEREAS, The State of California requires that applicant's agents be named in the  
2 resolution, now, therefore, be it

3           RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
4 authorizes the Executive Director of the Department of Emergency Management, or in his or  
5 her absence, the Chief Financial Officer of the Department of Emergency Management, or the  
6 General Manager of the Bay Area UASI, or the Chief Financial Officer of the Bay Area UASI,  
7 or the Controller of the City and County of San Francisco to execute for and on behalf of the  
8 City and County of San Francisco, a public entity established under the laws of the State of  
9 California, any applications necessary for the purpose of obtaining federal financial assistance  
10 provided by the federal Department of Homeland Security and sub-granted through the State  
11 of California under the FY 08 Homeland Security Grant Program (which includes the FY 08  
12 Urban Areas Security Initiative (UASI) grant, the FY 08 Metropolitan Medical Response  
13 System (MMRS) grant, the FY 08 Citizen Corps Program (CCP) grant, and the FY 08 State  
14 Homeland Security Grant Program), the FY 07 and FY 08 Buffer Zone Protection Program


