4 **premises license to Joel Bleskacek for Ruby Wine, LLC dba Ruby Wine, located at 1419**  
5 **18<sup>th</sup> Street (District 10), will serve the public convenience and necessity of the people of**  
6 **the City and County of San Francisco, in accordance with Section 23958.4 of the**  
7 **California Business and Professions Code, with conditions.**

10 WHEREAS, Joel Bleskacek is seeking the issuance of a Type 42 on-sale beer  
11 and wine public premises license for Ruby Wine, LLC dba Ruby Wine, located at 1419  
12 18<sup>th</sup> Street (District 10); and,

13 WHEREAS, The Planning Department has verified that the area is properly  
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business  
18 and Professions Code, the Board of Supervisors of the City and County of San  
19 Francisco hereby determines for the foregoing reasons that the issuance of a Type 42  
20 on-sale beer and wine public premises license to Joel Bleskacek for Ruby Wine, LLC  
21 dba Ruby Wine, located at 1419 18<sup>th</sup> Street, will serve the public convenience and  
22 necessity of the people of the City and County of San Francisco.

23 Conditions: (1) There shall be no coin operated games or video machines  
24 maintained upon the premises at any time. (2) No noise shall be audible beyond the  
25 area under the control of the licensee(s). (3) No person under the age of twenty-one

1 (21 years of age) shall sell, furnish, or deliver alcoholic beverages. (4) The interior  
2 lighting maintained therein shall be sufficient to make easily discernible the appearance  
3 and conduct of all persons and patrons in that portion of the premises where alcoholic  
4 beverages are sold, served, delivered or consumed. (5) The exterior of the premises  
5 shall be equipped with lighting of sufficient power to illuminate and make easily  
6 discernible the appearance and conduct of all persons on or about the premises.  
7 Additionally, the position of such lighting shall not disturb the normal privacy and use of  
8 any neighboring residences. (6) Graffiti shall be removed from the premises and all  
9 parking lots under the control of the licensee within 72 hours of application. If the graffiti  
10 occurs on a Friday or weekend day, or on a holiday, the licensee shall remove the  
11 graffiti within 72 hours following the beginning of the next weekday.
