3 **Resolution authorizing the San Francisco Department of Public Health (DPH), to accept**
4 **and expend retroactively a grant in the amount of \$10,566 from the Public Health**
5 **Foundation Enterprises (PHFE), the primary contractor, with funds from the National**
6 **Institutes of Health, to support a study entitled "Aripiprazole to Reduce**
7 **Methamphetamine Use among MSM with HIV," for the period of September 28, 2007**
8 **through July 31, 2008.**

10 WHEREAS, PHFE is the recipient of a grant award from the National Institutes of
11 Health (NIH), for a project titled "Aripiprazole to Reduce Methamphetamine Use among MSM
12 with HIV;" and,

13 WHEREAS, It is considered in the best interest of NIH, PHFE, and DPH to participate
14 in this project; and,

15 WHEREAS, PHFE has agreed to reimburse DPH in the amount of \$10,566 under the
16 terms of this agreement for the period of September 28, 2007 through July 31, 2008; and,

17 WHEREAS, As a condition of receiving the funds PHFE requires DPH to enter into an
18 agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of
19 Supervisors in File No. 080901, which is hereby declared to be a part of this resolution as if
20 set forth fully within; and,

21 WHEREAS, The grant does not require an ASO amendment and partially reimburses
22 the department for one existing position, a Senior Physician Specialist (Job Class 2232) at .05
23 FTE for the period of September 28, 2007 through July 31, 2008; and,

24 WHEREAS, A request for retroactive approval is being sought because DPH did not
25 receive the required documents from PHFE until May 20, 2008; and,

1 WHEREAS, The budget includes a provision for indirect costs of \$1,948; now
2 therefore, be it

3 RESOLVED, That DPH is hereby authorized to accept and expend retroactively a grant
4 in the amount of \$10,566 with PHFE, the primary contractor, for services under the project
5 entitled "Aripiprazole to Reduce Methamphetamine Use among MSM with HIV;" and, be it

6 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
7 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,
8 be it

9 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
10 agreement on behalf of the City; and, be it

11 FURTHER RESOLVED, That the Controller is directed to designate all positions
12 funded under this agreement as "G" or grant-funded positions which would terminate when
13 the agreement expires.




