8 WHEREAS, The San Francisco Foundation's environmental fund provides funding to
9 non profits organizations and public agencies to promote sustainable practices and equitable
10 development that guarantee livable communities and healthy environments; and,

11 WHEREAS, The Youth Stewardship Program has been engaging youth, 3rd-12th grade
12 in habitat restoration and environmental education projects in parks city-wide for the past the
13 ten years; and,

14 WHEREAS, The Youth Stewardship Program meets the objectives of the San
15 Francisco Foundation environmental fund; and,

16 WHEREAS, The San Francisco Foundation's grant will be allocated to non-profit Urban
17 Service Project for Contractual services; and,

18 WHEREAS, The grant does not include indirect funds to maximize the use of the
19 grant.

20 WHEREAS, The grant does not require an ASO amendment;

21 WHEREAS, The Recreation and Park Commission by Resolution number 0703-007 did
22 recommend the San Francisco Board of Supervisors to accept and expend a grant in the
23 amount of \$18,000 from the San Francisco Foundation for the Recreation and Park
24 Department's Volunteer Services Division.

11 Grant Agreement; and, be it

12 FURTHER RESOLVED, That the City and County of San Francisco appoints the
13 Director of Volunteer Services of the Recreation & Parks Department as agent to conduct all
14 negotiations, execute and submit all documents including, but not limited to applications,
15 agreements, and so on, which may be necessary for the completion of the aforementioned
16 program.


