

1 [Agreement with Cypress Security LLC. for Armed and Unarmed Security Guard Services]

2 **Resolution authorizing a three year agreement, with option to renew for up to an**
3 **additional three years, with Cypress Security LLC. for an amount not to exceed**
4 **\$15.8 million.**

6 WHEREAS, The San Francisco Municipal Transportation Agency (SFMTA) collects
7 more than \$200 million in annual revenue from transit fares, citation payments and sales of
8 various fare media and has more than 15 facilities throughout the city, including transit
9 stations, vehicle storage yards and service centers; and,
10

11 WHEREAS, These facilities require the services of armed and unarmed security
12 guards to act as a first deterrent for inappropriate activities and for the safety of SFMTA
13 personnel, to protect SFMTA property and the public, and to guard against vandalism; and,

14 WHEREAS, The current contract will expire on August 31, 2008; and,

15 WHEREAS, A Request for Proposal was released on May 20, 2008 that resulted in
16 four responses from potential contractors and,

17 WHEREAS, After evaluation of the bids submitted to determine whether they meet
18 minimum qualifications and the 5 percent Local Business Enterprise (LBE) subcontracting
19 goal, Comprehensive Security Services Inc. was identified as the lowest responsive and
20 responsible bidder

21 WHEREAS, Negotiations with Comprehensive Security were not successful and the
22 SFMTA subsequently entered into successful negotiations with Cypress Security LLC.; now,
23 therefore, be it

24 RESOLVED, That the Board of Supervisors authorizes the San Francisco Municipal
25 Transportation Agency to execute the Agreement For Armed And Unarmed Security Guard

1 Services with Cypress Security LLC.. for a term of three years, with option to renew for up to
2 an additional three years, for an amount not to exceed \$15,800,000 million in substantially the
3 form on file with the Clerk of the Board of Supervisors in File No. 08I035.


