3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**  
4 **submit a 12-month cost extension application in order to continue to receive funding**  
5 **for the HIV prevention Projects grant from the Centers for Disease Control and**  
6 **Prevention (CDC); in the amount of approximately \$8,800,000 in HIV prevention funding**  
7 **for San Francisco, extending the project period from December 31, 2008 to December**  
8 **31, 2009.**

10 WHEREAS, The San Francisco Board of Supervisors passed Ordinance No. 265-05 in  
11 November 2005, amending Section 10-170 of the Administrative Code to require Board  
12 review of proposed annual or otherwise recurring grant applications of \$5,000,000 or more  
13 prior to their submission; and,

14 WHEREAS, DPH is currently a recipient of the HIV Prevention Programs grant in the  
15 amount of \$8,824,991 from the CDC; and,

16 WHEREAS, SFDPH uses these funds to cover a multitude of HIV prevention programs  
17 for San Francisco residents, with 35 percent of the total award used for administrative costs  
18 (including planning, evaluation, coordination of programs, and contract management) and the  
19 remaining 65 percent subcontracted to qualified contractors selected through RFP to provide  
20 direct services to clients; and,

21 WHEREAS, Ordinance No. 265-05 requires that City Departments submit applications  
22 for approval at least 60 days prior to the grant deadline for review and approval; and,

23 WHEREAS, While the CDC released the application announcement on July 9, 2008  
24 with a due date of August 22, 2008 allowing just 44 days for the entire process; and,




