

1 [Accept- Expend State Grant]

3 **Resolution authorizing the Mayor's Office of Criminal Justice (MOCJ) to**
4 **accept and expend funds in the amount of \$2,294,774 from the State**
5 **Corrections Standards Authority (CSA), from funds made available under**
6 **Senate Bill 736 – known as the Juvenile Justice Crime Prevention Act**
7 **(JJCPA) – for programs and approaches that have been demonstrated to**
8 **be effective in reducing delinquency, for the period of July 1, 2008 to June**
9 **30, 2009.**

11 WHEREAS, MOCJ is the lead programmatic and fiscal agency of the
12 county in administering JJCPA, which provides funds for the county to implement
13 a comprehensive, multi-agency juvenile justice plan; and

14 WHEREAS, the JJCPA requires that the county's local Juvenile Justice
15 Coordinating Council, whose membership is described in Section 749.22 of the
16 Welfare and Institutions Code, update its Comprehensive Multi-agency Juvenile
17 Justice Plan (also know as its Juvenile Justice Local Action Plan) and develop an
18 annual expenditure plan for JJCPA funds; and

19 WHEREAS, JJCPA also requires that the county Board of Supervisors,
20 and in the case of a city and county the Mayor, approve the updated
21 Comprehensive Multi-agency Juvenile Justice Plan and the JJCPA expenditure
22 plan; and

23 WHEREAS, the City originally established the Juvenile Justice
24 Coordinating Council through resolution 170-97; and

1 WHEREAS, the Chief Probation Officer, William P. Siffermann, serves as
2 chair of the Juvenile Justice Coordinating Council as required by JJCPA and
3 Section 749.22 of the Welfare and Institutions Code; and

4 WHEREAS, on March 31, 2008 the Juvenile Justice Coordinating Council
5 met and recommended to the Board of Supervisors the updated Comprehensive
6 Multi-agency Juvenile Justice Plan and the expenditure plan for the 2008
7 allocation of the JJCPA grant;

8 WHEREAS, the grant does not require an ASO amendment; and

9 WHEREAS, the grant budget includes a provision for indirect costs of
10 \$11,474 (the maximum amount allowed by the state); now, therefore be it

11 RESOLVED, that the City and County of San Francisco hereby authorizes
12 MOCJ to accept and expend \$2,294,774 from the State Corrections Standards
13 Authority under JJCPA for programs and approaches that have been
14 demonstrated to be effective in reducing delinquency; and

15 BE IT FURTHER RESOLVED, all interest earned and prior year
16 unencumbered funds of this grant is appropriated to support approved 2008
17 JJCPA programs;

18 BE IT FURTHER RESOLVED that the County assures that the Board of
19 Supervisors has reviewed and approves the county's update to the
20 Comprehensive Multi-agency Juvenile Justice Plan; and

21 BE IT FURTHER RESOLVED that the Violence Prevention Director of the
22 Mayor's Office of Criminal Justice is authorized to sign the application for
23 approval submitted to the Corrections Standards Authority; and

1 BE IT FURTHER RESOLVED that the City and County of San Francisco
2 assures that it has adhered to the requirements of JJCPA and of the Corrections
3 Standards Authority regarding the submission of the plan; and

5 BE IT FURTHER RESOLVED that the plan has been developed and
6 provided to the Corrections Standards Authority in a format determined by the
7 Corrections Standards Authority regarding submission of the Plan; and

9 BE IT FURTHER RESOLVED that the City and County of San Francisco,
10 upon approval from the Corrections Standards Authority, will adhere to the
11 requirements of the JJCPA regarding the expenditure of JJCPA funds and the
12 submission of required Corrections Standards Authority reports; and

14 BE IT FURTHER RESOLVED that the Controller is directed to designate
15 the position funded under this agreement as a "G" or grant-funded position which
16 would terminate when the agreement expires.




