9 utilize grant funds available through the Juvenile Accountability Block Grants (JABG) Program
10 administered by the Corrections Standards Authority (hereafter referred to as CSA); and

11 WHEREAS, the grant does not require an ASO amendment;

12 NOW, THEREFORE, BE IT RESOLVED, that the Violence Prevention Director of
13 MOCJ is authorized, on behalf of the City and County of San Francisco Board of Supervisors
14 to submit the JABG application to CSA and is authorized to sign the Grant Agreement with the
15 SCA, including any amendments thereof.


16 BE IT FURTHER RESOLVED that the Board of Supervisors hereby waives inclusion of
17 indirect costs in the grant budget.

18 BE IT FURTHER RESOLVED that the City and County of San Francisco agrees to
19 provide all matching funds required for said project (including any amendment thereof), and
20 abide by the statutes and regulations governing the JABG Program as well as the terms and
21 conditions of the Grant Agreement as set forth by the CSA.


BE IT FURTHER RESOLVED that grant funds received hereunder shall not be used to supplant expenditures controlled by this body.




