3 **Resolution authorizing the Department of Public Library to accept and expend a grant**  
4 **in the amount of \$11,828 from the California State Library as part of the Federal Library**  
5 **Services and Technology Act (LSTA) for reimbursing tuition expenses of library**  
6 **employees pursuing a degree or certificate in library science at an institution of higher**  
7 **education.**

9 WHEREAS, The California State Library's Public Library Staff Education Program is  
10 dedicated to providing tuition reimbursement for library staff pursuing a degree or certification  
11 in Library Science; and,

12 WHEREAS, Ten (10) non-professional employees of the Public Library applied to the  
13 California State Library to participate and receive specific tuition reimbursement amounts and  
14 three were accepted into the program; and,

15 WHEREAS, The California State Library has awarded \$11,828 to the Public Library to  
16 reimburse the students/employees for Summer 2008, Fall 2008, and Spring 2009 tuition fees;  
17 and,

18 WHEREAS, Students/employees will provide official transcripts and registration fee  
19 receipts as evidence of completing said classes prior to receiving reimbursement; and,

20 WHEREAS, The Public Library has a goal of promoting equal access to professional  
21 development opportunities for all employees; and,


22 WHEREAS, the grant does not require an ASO amendment; and,

23 WHEREAS, The California State Library requires that all indirect grant costs not be  
24 allowed and must be provided in-kind by the recipient library; now therefore, be it
