[Extended Producer Responsibility Framework]

Resolution urging the California State Legislature to enact legislation based on the Extended Producer Responsibility Framework policy adopted by the California Integrated Waste Management Board that will shift costs and responsibilities for waste management from local governments to the producers of products and incentivize product redesign.

WHEREAS, Manufactured products and packaging constitute about seventy-five percent of the waste materials managed by the City and County of San Francisco and sent to landfill, costing San Francisco residents and businesses about \$150 million a year in refuse rates plus millions more in taxes to manage; and

WHEREAS. There are significant environmental and human health impacts associated with products that contain toxic ingredients, including mercury, lead, cadmium and other toxic chemicals that when disposed of improperly can contaminate soil and water supplies; and;

WHEREAS, When products are designed to contain hazardous chemicals and are then uniformly banned from municipal landfills by the State, the burden to manage these items at the end of their useful life falls to local jurisdictions in the form of specialized waste collection and public outreach programs; and

WHEREAS, Extended Producer Responsibility is an environmental policy approach in which producers assume responsibility-financial and/or physical-for the management of products at the end of their useful life, so that those who produce and sell products bear the costs of recycling and proper disposal; and

WHEREAS, In February 2006, the San Francisco Board of Supervisors adopted a resolution calling for statewide efforts to hold producers responsible for product waste and adopt policies that support Extended Producer Responsibility; and

WHEREAS, The current approach to legislating responsibility for end-of-life management of individual product types at the State level has been piecemeal and does not provide producers with incentives to design their products with recycling, reduced toxicity, and take-back in mind; and

WHEREAS, An Extended Producer Responsibility Framework Approach is a comprehensive environmental policy that establishes requirements and guidelines for the development of collection processes funded by product producers that provide convenient and sustainable opportunities for recycling or disposal by the public; and

WHEREAS, In January, 2008 the California Integrated Waste Management Board adopted an "Overall Framework for an Extended Producer Responsibility System in California"; now, therefore be it

RESOLVED, That the Board of Supervisors urges the California state legislature to enact legislation based on the Extended Producer Responsibility Framework policy adopted by the California Integrated Waste Management Board that will shift waste management costs and responsibilities from local government to the producers of the products, and which will give producers the incentive to redesign products to make them less toxic and wasteful, more durable and repairable, and easier to reuse, recycle and compost.
