3 **Resolution authorizing the San Francisco Department of Public Health (DPH), to accept**
4 **and expend retroactively a grant in the amount of \$13,242 from the Public Health**
5 **Foundation Enterprises (PHFE), the primary contractor, with funds from the National**
6 **Institutes of Health, to support a study entitled "Aripiprazole Treatment for**
7 **Methamphetamine Using MSM;" for the period of August 1, 2008 through July 31, 2009.**

9 WHEREAS, PHFE is the recipient of a grant award from the National Institutes of
10 Health (NIH), for a project titled "Aripiprazole Treatment for Methamphetamine Using MSM;"
11 and,

12 WHEREAS, It is considered in the best interest of NIH, PHFE, and DPH to participate
13 in this project; and,

14 WHEREAS, PHFE has agreed to reimburse DPH in the amount of \$13,242 under the
15 terms of this agreement for the period of August 1, 2008 through July 31, 2009; and,

16 WHEREAS, As a condition of receiving the funds PHFE requires DPH to enter into an
17 agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of
18 Supervisors in File No. 081210, which is hereby declared to be a part of this
19 resolution as if set forth fully within; and,

20 WHEREAS, The grant does not require an ASO amendment and partially reimburses
21 the department for one existing position, a Senior Physician Specialist (Job Class 2232) at .05
22 FTE for the period of August 1, 2008 through July 31, 2009; and,

23 WHEREAS, The Board of Supervisors approved the first year of funding for this project
24 on June 24, 2008, through File Number 080902, Resolution Number 292-08; and,

1 WHEREAS, A request for retroactive approval is being sought because DPH did not
2 receive the required documents from PHFE until August 25, 2008; and,

3 WHEREAS, The budget includes a provision for indirect costs of \$2,441; now
4 therefore, be it

5 RESOLVED, That DPH is hereby authorized to accept and expend retroactively a grant
6 in the amount of \$13,242 with PHFE, the primary contractor, for services under the project
7 entitled "Aripiprazole Treatment for Methamphetamine Using MSM;" and, be it


8 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and

12 agreement on behalf of the City; and, be it


13 FURTHER RESOLVED, That the Controller is directed to designate all positions


